

TWG BRL Sweepstake Official Rules

1. **HOW IT WORKS:** On occasion TWG BRL, LLC will offer sweepstakes thru one of its brands. During the Promotional Period, contestants may visit participating TWG BRL, LLC locations dba Cap n' Cork, Vine & Table or Big Red Liquors ("Sponsor") locations in Indiana and enter for a chance to win one or more grand prizes. The odds of being selected as a winner depend upon the number of entries throughout the duration of the promotion.

2. **ELIGIBILITY:** Only open and offered to legal TWG BRL VIP Members who have a valid ID and who are 21 years of age or older at the time of entry. Employees of Sponsor and immediate family members and individuals residing in their same household are not eligible to participate. Void where prohibited.

3. **HOW TO PLAY:** Visit any participating TWG BRL, LLC store, scan the posted QR Code to access the digital Entry Form, **you will be given a confirmation barcode that will need to be scanned in at any official TWG BRL, LLC register to complete the entry. CONTEST ENTRY OCCURS at the time confirmation barcode is scanned at the register and this code is associated with customer VIP profile.** Entrants must be registered as a TWG BRL, LLC VIP Rewards customer from a TWG BRL, LLC store in Indiana to be entered to win. By completing the Entry Form, you consent to joining the TWG BRL, LLC VIP Rewards program, and consent to receiving promotional notifications and will realize full VIP membership benefits. 4. **HOW TO PLAY WITHOUT A SMART PHONE TO SCAN QR CODE:** To enter giveaway in store without access to a smart phone to scan QR Code, qualified customers can provide entry details to any TWG BRL, LLC Associate, who will create an entry at the register and associate with the customer account. Or qualifying VIP may provide the following details on a card and postmark to TWG BRL, LLC Corporate offices (5445 S. East Street, Indianapolis, IN 46227). Entry details must include complete name, address, zip code, date of birth (mm/dd/yyyy), valid daytime and evening phone numbers, email address, and TWG BRL sign-up location.
